Technological additives

Xanthan gum (E415), BHA (1b,E320), BHT (1b,E321)

Feeding instructions

(mouth syringes to be squeezed onto the horse's/foal's tongue)

Horses: 1 mouth syringe of 50 g per day for 10 days

Foals:

Before weaning: 20 g per day for 10 days

After weaning: 20 g to 35 g per day for 10 days

Do not exceed recommended daily quantities.

Packaging

Box with 10 mouth syringes of 50 g net

Carton with 50 mouth syringes of 50 g net

Anti-doping certificates

Each batch is officially certified by the LCH (following controls on final product, urine and blood of a horse receiving 3 times the recommended daily quantity). LCH certificates are available on www.twydil.com (by entering the batch number).

It is the user's responsibility to check that the product complies with local regulations.

Storage and precautions

Store in original pack in a cool dry place.

Minimum storage life (under proper storage conditions): until best before date shown on the mouth syringe.

Keep out of reach of children.
