Feeding instructions

Mix 1 sachet of 50 g per day to the normal ration for minimum 10 days.

Do not exceed recommended daily quantities.

Antidoping certificates

Each batch is officially certified by the LCH (following controls on final product, urine and blood of a horse having received 3 times the recommended daily quantity). LCH certificates are available on www.twydil.com (by entering the batch number). It is the user's responsibility to conform to the directives of the local competent authorities presiding over his region or country.
